The object of Crimes Against Property, e.g., robbery, bribery, and burglary, is to obtain money, property, or some other benefit.

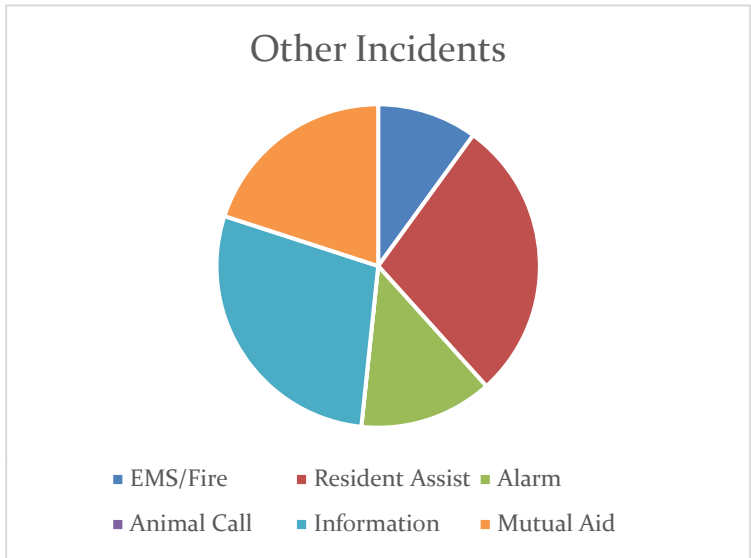
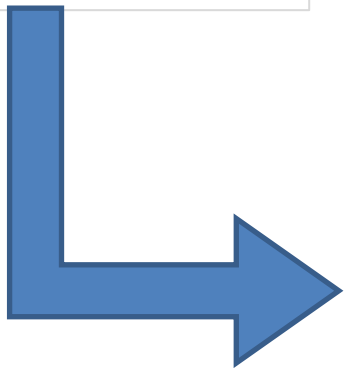
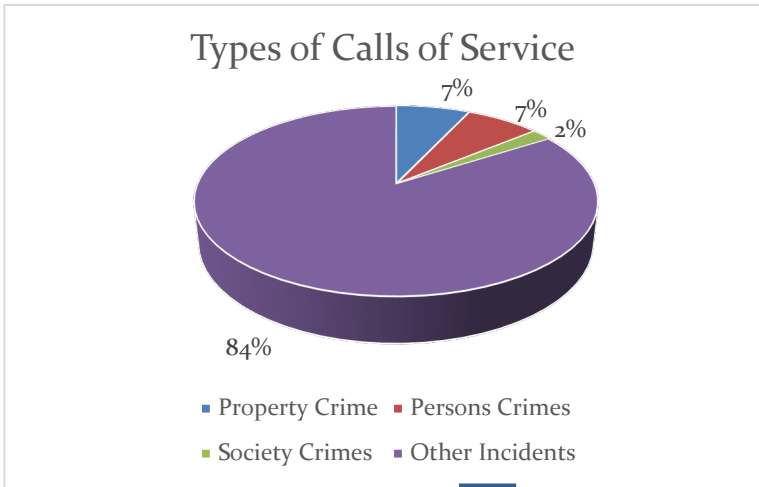

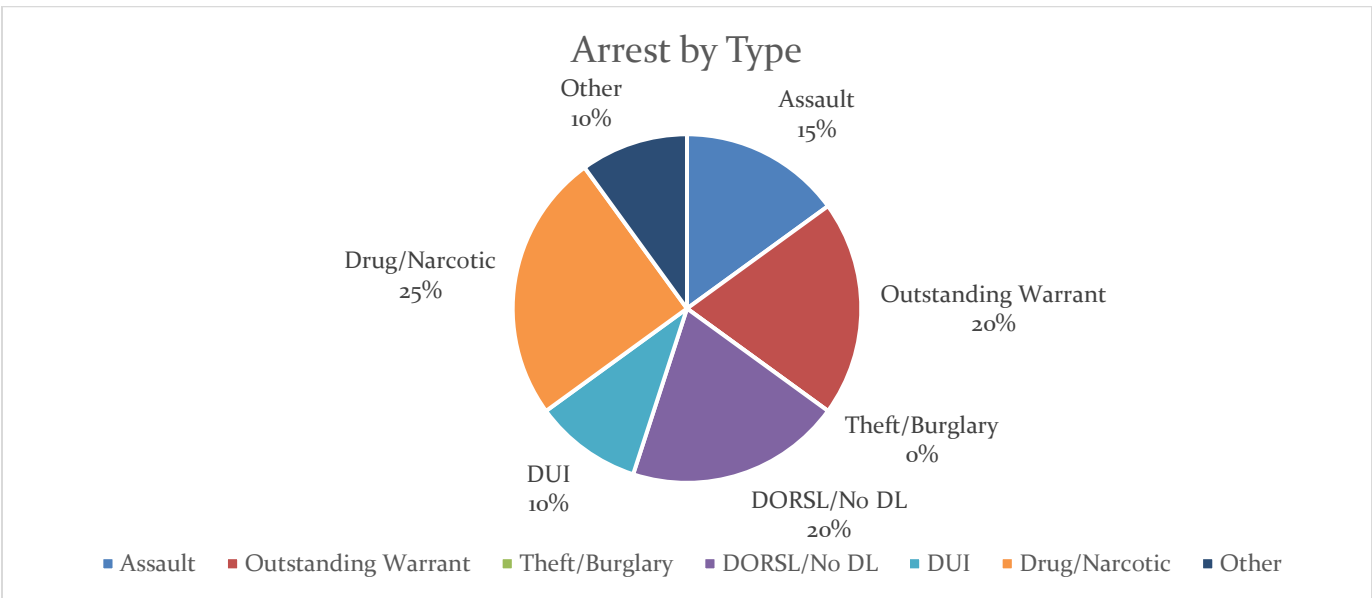

The arrest data represents physical arrests and citations issued in lieu of an arrest.

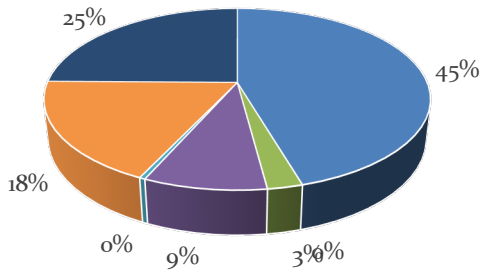

- Officer Wyatt is a certified officer that began his employment in January and has completed the accelerated field training program.
- Officer Janow began the basic law enforcement training academy at Tennessee Law Enforcement Training Academy (TLETA) in January.
- Sgt. Hammons completed the Glock Armour Course and certified armor for the department.

Department Highlights

- A minor accident matter of record form was implemented for vehicle accidents that do not meet the state threshold, of \$1,500, which will reduce the obligated time for the officers and provides the parties involved with an instant report on the scene.
- The FGCC IT team has begun the implementation of in-car video auto-downloading. This will increase efficiency, reduce manpower activity, and increase the security of department property.
- The department has begun implementation of a new software program that will consolidate community outreach programs (i.e. house watch program, key holder program, at-risk resident). This program will assist the agency in going green efforts to reduce office supplies, and increase accessibility to the officers and the public.
- Officer Wellness:
 - The department has implemented a program accessible to team members for mental health assistance. This program is confidential and the first step of initiatives to develop the department's Officer Wellness Plan. (Flyer attached)
 - The department has signed a contract with CMC wellness complex in Fairfield Glade for department members to utilize the facilities to promote physical wellness.

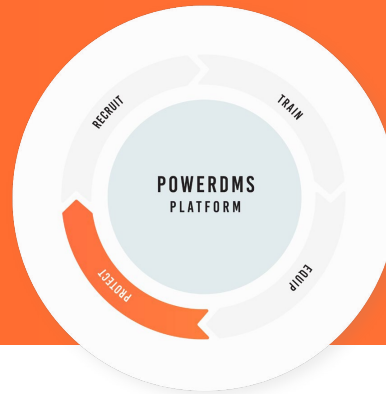

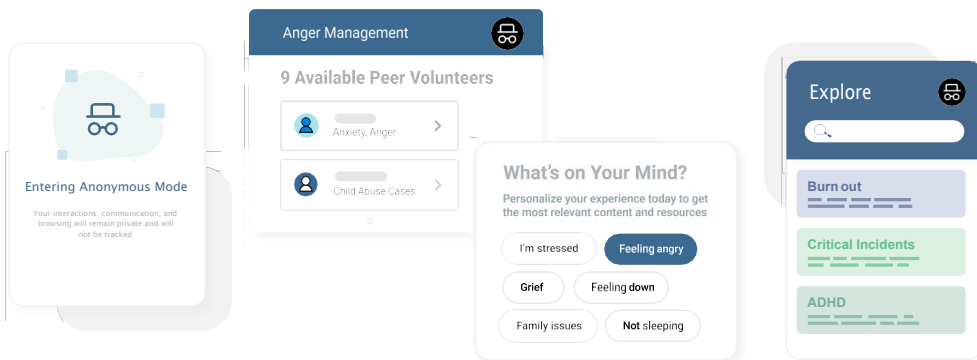
